COMES NOW, Plaintiff Jose DeCastro ("Plaintiff" or "I") hereby brings this first amended complaint against the above-named Defendants and requests a settlement meeting and or conference, and alleges on information and belief as follows:

INTRODUCTION

1. Plaintiff was employed as a constitutional activist and media content creator after studying and teaching constitutional law for over twenty years. Although Plaintiff has been arrested many times while exercising his constitutional rights to protest against racial inequality and the

despotism state America has obviously become, Plaintiff has not been convicted of a crime while protesting or otherwise. Plaintiff's only (misdemeanor) criminal records are historically over 20 years old.

- 2. Defendant Katherine Peter ("Peter") is a self-described "Internet Troll" that runs an online organization called "Masshole Troll Mafia" that is indeed an illegal criminal enterprise.

 Trolling is not simply with harmless online pranks. Trolling includes, but is not limited to harassing, stalking, and vandalizing targets. Peter identifies a target, in this case, the Plaintiff is the target and then the criminal activities begin. Peter has done this for years; Plaintiff has vowed to be the last victim of her illegal activities. All Peter need do is identify a target and the nightmare for them happens in an amorphous action of the organization's members, hiding behind internet anonymity as well as state and country borders for protection. Peter coordinates and facilitates the coordination of harassment and stalking of Plaintiff and his relations.
- 3. Peter, herself and through her agents, have conspired together and committed the following crimes and torts on Plaintiff: 1) defamed him by YouTube video and written article, by email, and by telephone calls; 2) defamed his products by YouTube video, Reddit, Facebook, Twitter and by written article, by email, and by telephone calls; 3) interfered with his contracts and prospective economic advantage; 4) stalked him online and in person, harassed him online and in person, trespassed, assaulted, and battered him; 5) used his name, voice, and photograph or likeness for unauthorized commercial use; and 6) committed wholesale copying of his creative content. These tortious acts were committed with malice aforethought as Defendants knew that they would cause him harm and they did cause him economic harm, emotional harm, and physical harm, and will continue to cause him harm in the future. Plaintiff warned Peter for over six months before finally taking legal actions against her and her Troll Mafia.

JURISDICTION AND VENUE

4. General Jurisdiction is proper in this Court because the unlawful practices alleged herein

were committed by Defendants within the County of Los Angeles and the harm occurred within that county and the amount of damages sought exceeds the minimum jurisdiction of this Court.

- 5. This Court has general personal jurisdiction because significant parts of the stalking, harassment, assault, and battery occurred in California, primarily in the County of Los Angeles. Defendants' emails and phone calls to California have been substantial, continuous, and systematic. (Code Civ. Proc., § 410.10 and *Perkins v. Benguet Consol. Mining Co.* (1952) 342 U.S. 437 [72 S.Ct. 413, 96 L.Ed. 485].) At least one of Peter's agents is believed to be a resident of Los Angeles County.
- 6. This Court has specific personal jurisdiction because alleged source witnesses for Peter and her agents' defamation are allegedly in the County of Los Angeles. Additionally, the alleged judicial record cited from for the defamation, as alleged fact, is a judicial record of the County of Los Angeles. (*Calder v. Jones* (1984) 465 U.S. 783 [104 S.Ct. 1482, 79 L.Ed.2d 804].)
- 7. Venue is Proper in this Court under California Code of Civil Procedure § 395 because Plaintiff is a resident of the County of Los Angeles, and the events or omissions giving rise to these actions occurred in the County of Los Angeles. Additionally, this court offers online filing, which makes it more convenient for foreign parties that are part of this action due to California's long arm statutes.

PARTIES

- 8. Plaintiff Jose "Chille/Chelito" DeCastro is, and at all times herein mentioned was, an individual residing in Santa Monica, Los Angeles County, California. Plaintiff operates the YouTube channel "Delete Lawz".
- 9. Plaintiff is informed and believes, and on that basis alleges, that Defendant Katherine "Kate" Peter is an individual residing in the State of Massachusetts, County of Bristol. Peter operates the YouTube channel "Troll Mafia Official".
 - 10. Peter has said in the past, when harassing and stalking Plaintiff, Plaintiff's family

members, Plaintiff's investors, and other associates, that she did not act alone. Rather she conspired with others or through the doctrine of agency did cause this harassment to occur. Peter runs an online organization called "Masshole Troll Mafia" ("Masshole") that is indeed an illegal criminal enterprise that trolls (harasses, stalks, vandalizes, assaults, and batters) targets that Peter identifies. All Peter has to do is identify a target and the "trolling" happens in an amorphous action of the organization's approximately three thousand members, hiding behind internet anonymity as well as state and country borders for protection. Peter coordinates and facilitates the coordination of harassment and stalking of Plaintiff and his relations by her agents.

- 11. Plaintiff is informed and believes, and on that basis alleges, that Defendant Daniel Clement ("Clement") is an individual residing in the State of California, County of Los Angeles. Clement is an agent of Peter.
- 12. Plaintiff is informed and believes, and on that basis alleges, that Defendant Michael Pierattini ("Pierattini") is an individual residing in the State of Washington, County of Pierce. Pierattini is an agent of Peter. Pierattini has hidden behind a false identity for many years, running a troll channel on YouTube named "Blue Bacon", where he harasses people, including Plaintiff, behind a false identity pretending to be a private investigator and military police officer.
- 13. Plaintiff is informed and believes, and on that basis alleges, that Defendant David Omo Jr. ("Omo") is an individual residing in the state of Texas, County of Dallas. Omo is an agent of Peter. Omo has anonymously run a troll channel on YouTube named "Team Skeptic", where he harasses people, including Plaintiff. Omo has a felony conviction for Manslaughter and Plaintiff attacks his credibility under Cal. Evid. Code § 788.
- 14. The true name or capacities, whether individual, corporate, associate, or otherwise of defendants Doe 1 to Doe 30, inclusive, are unknown to Plaintiff, who therefore sues such defendants by such fictitious names, and will amend this complaint to show their true names and capacities when ascertained. Plaintiff is informed and believes and thereon alleges that each of the defendants

designated as a Doe is negligently responsible in some manner for the events and happenings herein referred to, and thereby proximately caused injuries and damages to the Plaintiff as herein alleged.

FACTS COMMON TO ALL CAUSES OF ACTION

- 15. The allegations of this complaint stated on information and belief are likely to have evidentiary support after a reasonable opportunity for further investigation or discovery.
- 16. Plaintiff is informed and believes and thereon alleges that, at all times herein mentioned, Defendants Doe 1 through Doe 30 were agents of each other and of the named defendants and, in doing the things alleged in this complaint, were acting in the scope of such agency and with the permission and consent of Defendant Katherine Peter.
- 17. Peter is the owner, operator, and a user of a group messaging platform on the Discord service ("Discord"). The Discord is used by Masshole members to conspire directed harassment attacks on multiple victims. The harassment includes email, telephone, and public sharing of personal information that can further be used to harass those individuals called "doxing". Crimes against victims doesn't stop at harassment, but includes vandalism, stalking, harassment of victim family members and employers, and assault. There are over 2,800 Masshole Members on the Discord account, owned and operated by Peter. Sharing of images, text messaging, and voice chat is available on the Discord. Peter has admitted to tracking Plaintiff on the server "like an endangered great white" on the Discord.

FIRST CAUSE OF ACTION FOR LIBEL, SLANDER, AND FALSE LIGHT

- 18. Plaintiff incorporates by reference paragraphs 1 through 17, inclusive, as though fully set forth herein.
- 19. Plaintiff, who previously enjoyed a good reputation in the community, was defamed by Defendant's assertions that he had "Once Sold The Date Rape Drug And Might Be A Snitch, Will Sue us for Mocking him". A screenshot of the publication containing the defamatory statements is

attached to this complaint as **EXHIBIT 1**. Such assertions were published to at least one third party in that YouTube video was viewed 12,716 times as of February 1, 2023. The number of times the title of the video was read is not available until after discovery. Additionally, the video shows up in search results for Chille DeCastro (Plaintiff's well-known nickname), "Jose Maria DeCastro", and "Delete Lawz" (Plaintiff's brand).

- 20. The title of the article constitutes libel per se and statements in the video made by Peter and Pierattini constitute slander per se in that they use inaccurate documents acquired from BeenVerified (in violation of their Terms of Service, partly because of known accuracy issues), a consumer information service, presented as judicial record, to assert as factual that Plaintiff was convicted of a crime that he in fact did <u>not</u> commit. Such statements damaged Plaintiff as a natural consequence of the words, and amount to libel per se and slander per se.
- 21. Such assertions were false because Plaintiff was never convicted of nor did he plead guilty to selling any drug, especially a date rape drug. In fact, in the video, Peter claims that she is unable to get a record from the government. Instead of recognizing that the record doesn't exist, to add to the sting of the story, she asserts that this must mean that Plaintiff is a snitch. Even Peter's record from BeenVerified shows only an arrest, and not a conviction. As an activist, Plaintiff is often arrested, but has not been convicted, and this country's constitution is based on the principle of innocence until proven guilty.
- 22. The arrest record that Peter pulls from BeenVerified shows "POS/PUR F/SALE NARC/C/SUB". To add to the sting of the story in excess of the actual alleged judicial record, Peter alleges having spoken to four witnesses in Los Angeles County that say that the drug involved was GHB. Peter, with even additional malice to add more sting than the actual story, falsely asserts that GHB is primarily used as a date rape drug.
- 23. As a direct and legal result of Peter's publication of false assertions, Plaintiff has suffered the following damages in respect of his property, business, trade profession or occupation: damages

in the amount of approximately \$50,000 of compensatory damages and special damages according to proof related to emotional distress.

- 24. Statements were not privileged because they were published to YouTube and not to an internal method between people with a shared interest.
- 25. Plaintiff demanded a retraction within the statutory period and a retraction has still not been published. Instead, Peter said "sue me". See her video titled "Still Waiting For My LolSuit" in Exhibit 3.
- 26. Defendant knew that such statements were false, or acted with reckless disregard as to their truth or falsity, in that she knew that she did not have an official judicial record yet she didn't even report accurately on the record that she did have from the consumer database.

SECOND CAUSE OF ACTION FOR BATTERY

- 27. Plaintiff incorporates by reference paragraphs 1 through 26, inclusive, as though fully set forth herein.
- 28. On May 30, 2022, Peter traveled to the Memorial Day Parade in Boston just to confront Plaintiff. In her YouTube video titled "Chille, I'm So Sorry That I Upset You Josh Abrams is My Knight In Shining Puma!", recorded on the same day, she admits to this. Additionally, there are witnesses in the video that describe the existence of video evidence showing that she battered me multiple times. In the video, Peter states "I'm driving across town and checking in with Discord. Is he still there? Is he still there? Because he's squirrely. I went down there to have a confrontation with him and [he] wasn't getting away until that happened."
- 29. At the parade, she did in fact touch me multiple times without my permission, only to annoy, harass, offend, and cause me mental distress. She did in fact annoy, harass, offend, and cause me mental distress. Plaintiff went to the local police dept, Worchester MA, and filed a Police Report.
 - 30. On July 22, 2022, while I was at the Tahlequah Court house in Oklahoma and was

participating in a press release for a friend, a man that I know only as J.L. Warren, who is a dues paying member of Masshole Troll Mafia, showed up there and purposely ran into me and then tried to have me arrested for Battery. Mr. Warren has written me dozens of emails and hundreds of text messages, harassing me. I've clearly stated to Mr. Warren that I wish no contact with him and that I am not interested in interacting with him. On the same day he purposely ran into me, he called the police on me and tried to press charges against me for Battery. I was temporarily detained by police. It was terrifying because Mr. Warren caused physical contact between us. Thus, I was unaware if I would be arrested or not. Mr. Warren continues to contact me to this day and proudly proclaims, "I am a paying member of Masshole Troll Mafia. You can sue me, Chille."

THIRD CAUSE OF ACTION FOR TRESPASS

- 31. Plaintiff incorporates by reference paragraphs 1 through 30, inclusive, as though fully set forth herein.
- 32. At several of the places where I have rented property, I have suffered trespass from Peter and her agents, where they entered onto the property without permission and committed harm against the property and myself to terrorize me and in fact did cause significant alarm, fear, and caused damage to the property that required cleanup and repair.
- 33. On August 8, 2022, my van was stolen from my driveway. Masshole members on Discord have taken credit for stealing said vehicle; claiming they stole it!
- 34. On August 19, 2022, in a video where Peter published the findings of Denver Metro PD on my Stolen Van, she published the Address where I was staying in Denver on her Discord. Soon after, Peter and/or an agent left a bag of dog feces and card on the front door. I went to open the storm door, which had a lever type doorknob. When I pushed it down, the lever came off the security door. Under my fingers I felt a gooey brown substance, I immediately dropped the lever. It fell next to the bag of dog feces on my welcome mat. Next, my dog ran up and began licking up the brown

gooey substance. I yelled for him to stop. I smelled my hand. It was chocolate. I looked around. The handmade card on the door read, "Kate Always Wins". See **EXHIBIT 2**.

35. On October 25, 2022, while I was staying at a friend's house, my friend checked the mail and found a threatening letter in his mailbox. The letter stated:

Dear Jose DeCastro. I'm requesting you retract any and all lawsuits for a certain individual. If you proceed with the lawsuits I will be forced and will post your current address and location. Sir these little games you play have gone to far and you will be dealt with accordingly. You can run and hide but we can find you anywhere and anytime. It wasn't hard to locate the address you are currently at so tell Peter G. Hi!

Address: [CORRECT ADDRESS OF MY LOCATION REDACTED]
So here are the Terms. Retracts all lawsuits and take down your Youtube channel and find a different profession because you suck as a Constitutional Law Scholar."

36. While visiting a friend in New Hampshire and Boston in late August, early September 2022, Katherine Peter and/or her Masshole members, left a handful of balloons and a large, handmade sign (3' x 5') that read, "Kate's Tea Party" that were left at my friend's residence, attached to the old-school-mailbox. The location is a 450-acre estate, deep in the countryside of New Hampshire. For someone to get to the location in New Hampshire, driving more than an hour into the countryside is required. Thus, this wasn't a small endeavor, it took at least one full day to accomplish and likely two people to erect the "gifts" left behind. How Katherine Peter knew my location is beyond incredible and would have required massive surveillance or even a tracking device placed on my auto. During that same trip to visit a friend, Peter stalked and "marked my location" for her "Troll Mafia" to then target me at that location. Brazenly, Peter took a picture of herself sitting outside of the apartment's lobby where I was temporarily residing. Peter then posted the picture on her "Youtube community Page" that includes over 30,000 Masshole members, marking my location for further attacks. This is the reason DeCastro fled to the New Hampshire estate, only to be stalked and marked by Peter and her Troll Mafia again. DeCastro immediately left the estate and the East Coast after Peter had "marked" his location yet again.

FOURTH CAUSE OF ACTION FOR HARASSMENT AND CIVIL CONSPIRACY

(Plaintiff Against All Defendants)

37. Plaintiff incorporates by reference paragraphs 1 through 35, inclusive, as though fully set forth herein.

38. Peter made her first YouTube video harassing me, on April 3, 2022. The video was titled "BSBT Is Insane, Delete Lawz Grift, Turtleboy Goes Full Auditard". The video was over one hour long. The video said that I was running a "grift" and a "scheme", that I was a "schmuck", and a "sovcit schmuck from YouTube". Next, on that video, Peter visits the product store on my website, degrading and disparaging my product offering, including calling a T-shirt I sell, "a Shitty Microsoft word font typed t-shirt", which is not true. She continued to state, "I'm gonna' recreate his shit poster and I'm going to sell them for um, \$48 and it'll be no profit whatsoever. It'll be exactly what it costs to print on Vistaprint." Painting me in a Negative light by purporting that, the markup of the products (on my online store) is a scam, grift or con. She goes on to also threaten to copy my products and sell them at cost, just to hurt my business. These are statements that she makes on camera to her 30,000 Troll Mafia Members. As she is fraudulently representing my product lines, several other of Peter's agents speaking during the video make various defamatory claims about me.

39. Although the first video that Peter made was about Plaintiff, who is not a public figure or a limited public figure, the videos soon turned into directly harassing me by being directed at me. See the titles of later videos like "Sorry, Chille. Another One of Your Failures With More To Follow". Additionally, Peter has recorded these harassing videos even in contempt of court orders in a federal lawsuit. Peter published a video that said among other things "... because you are a quarter of a man," in her video "What To Do If You Get Doxxed – Chille Is A Quarter Of A Man", a video that she made after federal court judge Allison D. Burroughs ordered among other things "Defendants are ORDERED not to engage in any threatening, harassing, illegal, or otherwise inappropriate behavior when engaging with each other...". A motion for contempt against Peter is

currently pending in that court. Peter has made 70 videos totaling over 170 hours of content about Plaintiff (See **EXHIBIT 3**). These videos did seriously alarm and annoy me and did cause me substantial emotional distress and financial loss.

40. On May 3, 2022, Peter and her agents called my phone approximately 100 times while I was recording a video that I was broadcasting live to my audience, just to troll me. I was doing a live fundraiser for a Native American woman that had been illegally arrested on her tribal lands and I was trying to call her when the telephone harassment began. Peter and her agentss were watching my livestream and determined when it would be best to harass me, for example, when I needed to use my phone, they called the phone approximately 100 times. You can see this in my video titled "Deboraugh's Story – Fake Law vs Real Law – Ironton Bad Practices Fundraiser for \$Deboraugh" at timestamp 14:58 – 24:36. Even after I put my phone in do-not-disturb mode, the harassing texts were continuously coming in and audibly disturbing my phone call with my video guest for the fundraiser. The repeated telephone calls and text messages impacted the fundraising and seriously annoyed and harassed my guest and me. The video is available on YouTube at the following URL. After I was off air, I had approximately 100 missed calls. I tried calling one of the numbers back and it was a Google Voice number that Katherine Peter had set up with a voicemail message in her voice that said, "I told you to never threaten me, Chille." At the sound of the beep, I left a message and asked her to stop contacting me.

- 41. Peter also hired a man that I know only as Todd Lyon that attempted to be friend and then betray me. Todd and I talked several times by email, text, telephone, and even video chat.

 Eventually, Mr. Lyon admitted that he had been paid \$1,000 to attempt "to get close to me and then sabotage me". Mr. Lyon has prepared affidavits attesting to these facts.
- 42. Peter and her agents have repeatedly emailed, cyberstalked, stalked, harassed, and trespassed on my residence. Additionally, they commit wholesale copyright infringement of my

megalodon". As of February 3, 2023, while live-streaming a video titled, "The Camera is what

makes YOU Powerful" a Masshole member posted my exact location in the "Live Chat". The Masshole member went as far as to create a fake username in the true name of the friend's house that I was at. I ended the live stream to ensure my location was safe. I informed my friend that someone has created his exact name as a "YouTube username" and he immediately stated his concern for his safety, and mine. He did not ask me to leave, which has happened to me in the past when being stalked by Peter and her Troll Mafia. Nobody feels comfortable when a "Troll Mafia" publicly doxes your exact location. It causes immediate concern for safety. Peter cannot fully control the 30,000+ Masshole Troll Mafia members actions and she's stated this clearly, several times in the past, but she has given them authority to act to harass me. Obvious, malicious intentions exist to cause me and my loved one's fear and panic, which does in fact cause the fear and panic.

49. I have been stalked and harassed at my residences in New Hampshire, Boston, New Mexico, Colorado, Nevada and California. I have suffered from vandalism. My van was stolen, likely by Peter and/or her agents. Masshole Troll Mafia members on Discord have taken credit for the stealing of my van, stating that "It's under water and it will never be found".

50. In the Discord there is a page called "chille-watch" where my location has been constantly and consistently tracked and Peter and her Masshole agents have used this information to cause damage, intimidate and instill fear into me, but <u>more importantly</u>, to the people around me! I've been stalked since June of 2022, non-stop, and it's still going on today, right now.

51. It does not matter what I'm doing, where I'm going or who I am with. If I am livestreaming while filling my car up with gas, people from Katherine Peter's "Troll Mafia" will start calling the gas station attendant at that gas station. It's real and this entire scenario is on video that will be available at trial. The hosts of accommodations, where I stay when I am traveling the country, are contacted by telephone, email, and messages through Airbnb. Masshole members will then "warn" the people who are providing my Airbnb, "Did you know that DeCastro is a dangerous man who carries guns and is wanted by the police in multiple states?", which isn't true.

- 52. On July 29, 2022, I was attending an MMA gym in Denver Colorado. A Charity-Event-Fight Promoter, I, and a former Police Officer were putting together a charity event, wherein all the profits (including the Officers pay and mine) would be donated to St. Jude's Children Hospital. We had sold almost 1000 tickets (\$40 each) for the event, that I took seriously. Thus, I temporarily moved to Denver to join my good friend's MMA training center called, "Tenth Planet Jiujitsu". On this day, July 29, 2022, the owner of the gym, my 20 year long friend, sent me a text message, issuing me a refund and simply stating, "I'm sorry Chille. I can't get the google ratings down like this. I'm being harassed like you don't even understand! I just can't. I'm sorry!" The Harassment of said gym owner continued for several months, even after I left.
- 53. Approximately August 1, 2022. After being a member of Airbnb since 2010, I was unceremoniously and immediately kicked out of my Airbnb in Denver, Colorado. Airbnb would not reveal the reasons why. I've rented hundreds of locations from Airbnb since 2010. As an Ad Executive in NYC, it's imperative to have the ability to be able to rent Airbnb's quickly. On this date, Airbnb suspended my account indefinitely. "You've been assessed to be a risk factor. You are to immediately pack your belongings and leave the Airbnb, the host has canceled your month long reservation (this on Day 2 of the 30 day stay). Please standby for a phone call from the Airbnb safety and security team". On that phone call I was told that Airbnb had been alerted that I am armed and dangerous, "Are you carrying a gun? Is there a gun in the Airbnb". Of course not. However, a man named Sean O'Dea who goes by the name "Irish Demon" on Youtube and is also a dues Paying Member of Masshole, previously had posted on his linked-in Page that he worked as "Customer Service" for Airbnb for over six years. It is Plaintiff's intention to subpoena Airbnb to find out exactly what happened on August 1, 2022. Mr. DeCastro has never been asked to leave any rental property from Airbnb and has maintained a perfect 5-star rating on the application since 2010. After threatening a lawsuit, Airbnb restored "Permissions" to use my account in December of 2022 but I haven't seen the documents yet that caused the suspension.

54. On August 10, 2022, Peter made a YouTube video falsely reporting that my van was repossessed, simply to further harm my reputation and to further harass me. This, even after she had attained the Denver Police Dept. report that my Van was indeed stolen. Denver Police would later arrest and charge a woman for stealing my Van. Peter has made no retraction or corrected her erroneous reporting.

55. On October 6, 2022, while me and my roommate were walking home from the market in Santa Monica, California, while maybe 50 yards from my permanent residence, a man pulled up to us in a vehicle with Florida license plates and yelled "I see you, Chille! I know where you live! Kate always wins!", and then quickly drove away. This caused great alarm and fear in my roommate and myself. We went through weeks of infighting because my roommate feared for his autistic son's safety. It's beyond reasonable for Masshole Troll Mafia Members to show up at my house and threaten me, my roommate, and my safety.

56. My mother, immediate and extended family members, as well as dozens of my, small-town-friends (in Alaska) have received many harassing phone calls. I graduated with 62 young men in 1992, most of them have been contacted by Masshole Troll Mafia Members. My roommate, David Condon, has received harassment, trespass, and vandalism. Previous investors, colleagues and co-workers have received both calls questioning who I am and also warning that I have become a danger to them and they should stay away from me, "if they know what's good for them". One of Peter's agents, that I know as David Omo has been continuously emailing me, often multiple emails a day. Omo's email content has escalated to warnings of violence and then to actual threats of violence, including references to his felony criminal record to make them more credible. Pierattini has been sending me harassing emails, forged to look like they're from a court, two to three times a day since at least November 2022.

57. I have had dog poop left on my porch, my outside door handle covered in what looks like poop, and my external door handle removed. I have received gifts of balloons and cards about

"Kate's Tea Party" left at my residence. Peter has posted pictures of herself on her YouTube page in front of one of my temporary residences. Peter has paid a man one-thousand dollars to "Try to get close to me and sabotage me". I have the receipts and the man's affidavit, stating these facts.

58. As a result of the foregoing, I have legitimately feared for the safety of myself, my family members, and my associates and am constantly in a state of alarm. The Masshole Troll Mafia members work together to stalk me for clout in the organization and this constitutes clear conspiracy. The defendants work together in an agreement to commit these wrongful, illegal acts.

59. There are additional events that discovery will reveal and proof will be provided at trial. In this scope, but not limited to it, Katherine Peter will stalk, harass and assault any person who Plaintiff DeCastro recognizes or associates with. From August 27th until September 11, 2022, Katherine Peter tracked, stalked and harassed Zane Kane, the man whose residence DeCastro had stayed at in New Hampshire and Boston. When they could not affect Mr. Kane, Troll Mafia Members then found the owners of the property where Mr. Kane was residing. Troll Mafia Members warned the Land Owners (A Harvard Professor and her husband a Venture Capitalist) that Mr. Kane's friend, DeCastro, was armed, dangerous and wanted by the FBI; all lies. Plaintiff DeCastro had already left the East Coast and was not there to defend these lies. Mr. Kane was fired from his job and lost both of his residences as a result of the stalking. Peter would go on to make several videos about Mr. Kane, who had no relationship with her and had never even met her. Approximately, Jan 27, 2022, Plaintiff DeCastro publicly recognized a YouTuber named Regan Benson. Three days later, on Jan 30, 2022, Defendant Peter made a video about Regan Benson titled, "The Reagan Benson and Denver Metro Audits Mystery". This is an attempt to alienate and disrupt the First Amendment Auditor Community that DeCastro is a part of. Regan Benson had never previously been mentioned or referred to by Kathereine Peter.

SIXTH CAUSE OF ACTION

FOR ASSAULT

- 60. Plaintiff incorporates by reference paragraphs 1 through 59, inclusive, as though fully set forth herein.
- 61. On October 14, a member of Masshole Troll Mafia, who I know only as Dan Clement began plotting to get into a physical altercation with me in order to, at his own admission, cause me to lose possession of my firearm.
- 62. Clement had been in a fight in his past where he had a restraining order placed on him, and so he was aware of the repercussions of them. He wanted to use this tactic to cause me to lose my firearm.
- 63. On October 17, armed with bear spray, and a tape measure (to measure my height),

 Clement used the group's Discord chille-watch page to receive coordinates, plan, and get real time logistics of my location from several other Masshole Troll Mafia members, who were tracking my location in real time.
- 64. Clement quickly found me while I was working as a reporter for my YouTube Channel and engaged with officers of the Los Angeles Police Dept. While busy working, Clement, with the help of the Discord "chille-watch" tracking page created by Peter, Clement approached me and said "Kate always wins." Then he repeated it. "Kate Always Wins, Chille!" I addressed Clement, then I asked him to leave me alone and I walked the other way. Every action I'm describing here is on video, for this court to review.
- 65. Clement followed me and said that he could beat me up, "I could hold you down and then ground and pound you! Look how little you are!" he exclaimed. Again, I walked away, went the other way and quickly down the block to avoid having to protect myself from this stalker.
- 66. While down the block, moments later, Clement approached me again and somehow managed to corner me. After trying to go left, Clement blocked me. I tried to go right; Clement

blocked my path. I took a fighting stance ready to defend myself and announced to Clement that I would now begin an offensive-defense. Now that I was visibly angry and ready to defend myself, Clement ran away, quite literally crying, "Please, don't hurt me! Please, don't beat me up! I'm sorry!" Clement was then assisted by people who plaintiff could only believe were members of Katherine Peter's, Troll Mafia Club, who came to Clement's assistance. Clement would then appear on Peter's Discord and claim victory for "Trolling" me. Remember, Clement brought with him Bear Spray, Rope and a measuring tape, which would cause any reasonable person to fear for their safety.

67. I did believe that I was going to be attacked by Clement. Clement did in fact threaten me both verbally and was using physically menacing body maneuvering. I believed that he was going to carry out a physical attack onto me. Clement did in fact stalk me, menace me, and cause me ongoing mental distress, fear, and alarm. Clement continues to contact me to this day.

SEVENTH CAUSE OF ACTION FOR ECONOMIC INTERERENCE

- 68. Plaintiff incorporates by reference paragraphs 1 through 67, inclusive, as though fully set forth herein.
- 69. On May 2, 2022, Peter contacted David Condon ("Condon"), an accredited investor who had previously invested in my company. Condon has invested approximately \$100,000 into my ventures through the years and he and I had formed a close friendship. Condon told me that Peter wanted to "Interview him about my previous tech venture". Condon agreed and on May 3, 2022 the two talked at length on the phone. During the conversation, Peter did her best to paint me in a negative light. Condon has prepared an affidavit and will testify at trial.
- 70. On July 6, 2022, Peter called David Condon ("Condon") dozens and dozens of times and sent him approximately a hundred text messages. Mr. Condon is an accredited investor and a 65year-old man. The messages and people on the phone only said one thing, and the test messages said the same thing. That message was, "Kate Always Wins".

71. Peter knew of the agreement between Condon and I. Peter intended to cause breach of contract and did in fact harm the business relationship. Although Condon has prepared an affidavit, Peter's conduct was a substantial factor in Condon not investing any further in my projects.

EIGHTH CAUSE OF ACTION FOR RIGHT TO PUBLICITY TORTS

(Plaintiff Against All Defendants)

- 72. Plaintiff incorporates by reference paragraphs 1 through 71, inclusive, as though fully set forth herein.
 - 73. Defendants have used my likeness to advertise most of their YouTube videos about me.
- 74. The Defendants gained a commercial benefit because their following, as well as my following, were looking for content about me and used the images to find the content, which earned advertising revenue for the Defendants.
- 75. I was harmed by not having that ad revenue myself, by the videos containing negative content about me, and because as a trained actor, I charge fees and have been paid for my likeness.
- 76. As a direct result, I suffered financial loss, momentum to grow my brand, humiliation, embarrassment, mental distress, and economic harm.

PRAYER FOR RELIEF

Plaintiff prays for judgement against Defendants, and each of them, as follows:

- 1. Enter an injunction for any and all appropriate injunctive relief, including but not limited to, issuing a retraction in substantially as conspicuous a manner as the original defamatory statements were published and broadcast, and removing the defamatory information from all places where it is currently published online;
 - 2. A declaration that the defamatory statements were untrue;
 - 3. An injunction prohibiting Defendant from repeating such defamatory statements;
- 4. Declare, adjudge, and decree Defendants violated the relevant provisions of California Civil Code;

1	11. Order Defendants to pay any additional special and general damages according to proof;			
12	12. Award exemplary damages and \$86,000 in punitive damages pursuant to the requiremen			
13	of Civil Code Section 3294;			
14	13. Award Plaintiff attorney's fees and costs of suit;			
15	14. Order Defendants to pay interest at the legal rate on such damages as appropriate,			
16	including pre- and post-judgement interest; and			
17	15. Grant any further relief that this Court deems just and proper.




