## APPELLANT'S PETITION FOR ORDER TO CLERK AND FOR EXTENSION OF TIME TO FILE BRIEF

Appellant Craig Hendry, by undersigned counsel Kay A. Beehler, respectfully petitions the Court for an order to the Clerk of Vermillion County and for an extension of time to file his opening *Brief* and *Appendix*. In support of this request, Appellant states as follows:
