DECLARATION OF R. PAUL KATRINAK

I, R. Paul Katrinak, declare as follows:

1. I am an attorney duly licensed to practice law before all courts of the State of California. My law firm is counsel for Defendant Michael Pierattini ("Mr. Pierattini") in this action. The following facts are within my personal knowledge and, if called as a witness herein, I can and will competently testify thereto.

- 2. On February 21, 2025, I appeared at the continued hearing on Mr. Pierattini's Motion for Terminating Sanctions. Scott Geblin appeared at that hearing on behalf of Plaintiff. At the hearing the Court referred to a declaration by Plaintiff that was supposedly filed with the Opposition to the Motion for Terminating Sanctions.
