On March, 10, 2025 I responded to a report of shots fired at

When I arrived at the scene, Lane Myers was in the road in front of his residence. I spoke with Lane and attempted to get descriptions of anyone he might have seen, or any vehicle that had left the area, but Lane stated that he did not have his contacts in and could not provide any details at all for any possible suspects. I relayed this over the radio.

Lane then showed me to the north end of the home where the window had been broken and there was glass outside. Lane stated that he heard a noise outside and then heard a series of loud bangs and the glass being shattered and assumed it was gunfire, later determined to be two large rocks being thrown through the window. I did not observe any shell casings outside the window.

Lane then stated that I needed to contact the Federal Bureau of Investigations because his wife, Katherine Henrichs, is a Federal attorney who was the target of threats. Lane stated that she was on a walk with her two dogs and gave locations that she might be and I requested responding deputies to go to those areas and attempt to make contact with her, and deputies did locate Katherine safe and unharmed.

Lane eventually was able to describe how he had received an anonymous letter in the mail that he described as being a suicide note, but appeared to an amateur medical/mental health diagnosis. I took photos of the letter using Axon Capture and uploaded to Evidence.com. Lane then described an ongoing online argument that he has been embroiled in with a Youtube personality who goes by Direct D. Direct D is Christopher Dane Ruff.

Lane showed me excerpts of the online confrontation and stated that he would provide them as evidence through Axon Community Requests, which I provided a link for Lane to do. The confrontation appeared to be mostly adolescent insults. Lane also stated that he had made a report to Apache County Sheriff's Department in regards to Christopher Ruff making threats and provided the details of that report to other deputies.

I also spoke with Katherine who stated that she was concerned because of the rocks that had been thrown into her windows, but was unaware of the details of the online argument with Christopher Ruff. After Katherine was provided with Victim's Rights, I departed the scene and went back on patrol. NFI

On 03/10/25, at approximately 1950 hours, while patrolling the Rincon District, a call was received at the address of,

reference shots heard. I responded as a backup unit with the call text stating that someone shot window, three shots were fired, unknown who, but heard a vehicle drive off, negative injuries, the line then disconnected to speak with Deputies.

Deputy D. C. Dryden #9547 who arrived on scene first, advised over the air that the timeframe was six minutes, no vehicle description, unknown direction, then stated that it would be a Caucasian female, two dogs, one is a medium sized dog and one is a smaller dog, does not have clothing description on the female.

Deputy A. Duarte #9425 then advised that he was out with a female at the cross streets of Avenida Del Cornea & Placita Matate that matched the description. I then went to Deputy Duarte and backed him up on his contact with her. I then called Deputy Dryden to figure out more information on what he had got. I then asked the female who later verbally identified herself as Katherine Henrichs. I asked Katherine if there had been any verbal disputes between her and the male at the residence being Lane Myers. Katherine stated no. I asked Katherine if Lane had been acting out of his usual. Katherine stated that Lane had been arguing with people online recently. I asked Katherine what she meant by that, who was he arguing with, or what social media platform. Katherine was not answering the questions. She just kept stating: I don't know how to explain it.

Deputy Dryden then stated that Katherine was good to come back to the residence as she did live there. After speaking with Katherine, I then drove to the residence where the incident location was. I stood by while investigations were being conducted. Katherine showed to start getting emotional about the situation. I advised Katherine that everything would be okay and that everything would get figured out. I also explained to Katherine that it was not gunshots, it was a rock that was thrown through the window, according to Deputy Dryden. I then stood by further while investigation were further being conducted. After standing by, my help was no longer needed. I then advised Communications and returned to my assigned patrol duties.

This concludes my involvement.

NARRATIVE:

On 03/10/25, at approximately 1950 hours, while patrolling the Rincon District, I responded as a backup unit to shots fired at,

While en route, I was provided the following information via the call text, Lane Myers, who is the reporting party, someone shot the window, three shots were fired, unknown who, heard vehicle drive off, negative injuries, the line disconnects to speak with Deputies. Timeframe from six minutes, no vehicle description, unknown direction.

Before arriving to the location of incident, I conducted a search around the area trying to locate a female individual with the description of a Caucasian female, with two dogs, one medium sized dog and one smaller dog. I was in the area of Avenida De Corea & Placita Monte, just south of. At that point in time, I noticed a female individual who was wearing an orange windbreaker and black pants, as well as with two dogs. I stepped out of my patrol vehicle and approached the female individual who was identified as Katherine. I advised Katherine who I was and the department I worked for.

I explained to Katherine the reason I was out with her was because an incident just happened regarding to shots fired that happened not too long ago. Katherine explained to me that she did not hear anything. I explained to Katherine that they literally described a Caucasian female individual walking with two dogs. I explained to Katherine she was the only female individual I had seen so far with two dogs. However, Katherine explained to me that she did not hear any shots fired. She explained to me that she did not have any weapons on her person.

Katherine continued her story saying to me she had been walking the route she takes almost everyday and did not hear any shots go off. It explained to me that all Katherine did was just walk to her house on the street, went over a little

dirt path, and then was heading back home. Katherine also then provided me on her phone that showed me her route she had taken to walk. I explained to Katherine, if she once again possibly heard any shots go off or possibly any vehicles driving by. Katherine stated to me that she did not see any vehicles passing by.

I explained to Katherine, that she may possibly have something to do with the incident that happened in regarding to shots fired as well as explained to her that the reportee heard two shots going off and damage to the reportee's windows. However, Katherine explained to me that she had no idea what was going on and that she had just went to go out for a walk. Deputy J. Q. Palicte #9437 had interviewed with Katherine. Please see her report for further information.

I then made my way to the location of incident, however, I asked Deputy D. C. Dryden #9547 if my assistance was still needed and he stated no. I then cleared from the scene and returned to service.

NARRATIVE:

On 03/11/25, at approximately 1547 hours, while patrolling the Rincon District, I responded to a harassment at,

I was provided the following information via the call text stating the following, Katherine, who is the reporting party, there have been multiple posts online about Katherine's employment and false statements about her. Katherine believes it may be a connect up case that occurred, Case #250310262.

I proceeded to make telephonic contact with the phone number provided to me from Communications. I was able to get in contact over the phone with Katherine. Katherine explained to me the incident that happened on 03/10/25 regarding her boyfriend, Ray, who is a Youtuber and having some kind of dispute with another Youtuber named Christopher Ross. However, she explained to me that Christopher Ross did not live in Tucson, he lived somewhere north in Arizona, but was not to sure where he lived at.

Katherine continued to explain to me that today she saw on social media that Christopher Ross had made multiple posts about her yesterday on Twitter, basically tagging her employer, posting her work bio, and basically making false statements about Katherine stating that I had encouraged her boyfriend to commit crimes in which Katherine explained to me it was not true. Katherine continued to explain to me she had never met the person, but those were the posts that were made about her from Christopher Ross.

I explained to Katherine that I would send her an Axon link so that way she could provide me screen shots that she had taken. A link was then provided to her. I also explained to Katherine that the information she had provided to me

would be documented with the original case number I provided to her from the initial Deputy, Deputy D. C. Dryden #9547. This concluded my telephonic contact with Katherine.

At that time, I received a message on my Mobile Data Computer (MDC) saying that Katherine needed another link provided to her. However, I then proceeded to make contact over the phone with Katherine and explained to her that if she needed a new link provided to her. Katherine stated yes, as well as explained to me that she wanted to add new information.

Katherine then explained to me that two days ago on, 03/09/25, Christopher Ross had taken a screen shot and posted it on Youtube stated to me, "Also not fun when things start to get personal. Francis Pat Henry, join in disability, race Arizona, staff Attorney in October of 2024, and he keep playing games with my family, home, and business, wife, whatever you want. Around is fair play."

I asked Katherine if that was all of the information she would like to add to the report and she stated yes. I then provided Katherine with another Axon link due to her saying she had a screen shot of that incident. An Axon link was provided to her. I asked Katherine if she would like anything else to be added to the case and she stated no. I then cleared the scene and returned to service.

This concludes my involvement.

On 03/12/25 I made telephonic contact with Katherine Henrichs in reference to wanting add more evidence to her case.

Upon speaking with Katherine, she identified herself verbally and stated that she believed Christopher Ruff was responsible for the rock being thrown through Katherine's window. I asked Katherine what evidence she had to support this and Katherine stated all of her evidence was circumstantial. Katherine said that Christopher had posted things about her job and what she does at work that were not true. Katherine said that this started the day before the incident of the rock being thrown through her window by someone and that since then, Christopher has posted more mean things about Katherine. I asked Katherine if at any point Christopher had threatened her online and Katherine said he had not.

I provided Katherine with an Axon link to upload more screenshots of what Christopher had posted about her and explained that there wasn't anything connecting Christopher right now to the window being broken. Katherine wanted to know if she should get a protection order against Christopher and I told Katherine that if she felt that threatened by Christopher then she should do whatever feels right.

This concludes my conversation with Katherine.
