THE COURT FINDS that videotaping is not helpful in this case and can impede justice for both the Defendant and the Victim.

IT IS ORDERED that the motions for audio recording shall be granted, and the motions for video recording shall be denied.

Mark Brown and Mark Kelly argue to the Court.

The Court affirms the previous order.

As to Motion to Change Judge Pursuant to Rule 10.1:

IT IS ORDERED that the Defendant's motion to strike the State's response is Denied.

THE COURT DOES NOT FIND that there has been an interest or prejudice that would prevent a fair trial, as to the Violation of the Admin Order.

THE COURT DOES NOT FIND that there is a violation of Speedy Trial.

THE COURT DOES NOT FIND that there is anything argumentative or threatening against the Defendant, as to the Threat of Retaliation.

THE COURT FINDS that there is no prejudice or interest that would prevent a fair trial shown on behalf of the Hon. Judge Metcalf.

IT IS ORDERED that the Motion to Change Judge Pursuant to Rule 10.1 is Denied.

The Court and counsel confer regarding the possible plea agreement and the possibility of a *Donald* Record.

IT IS ORDERED that Mr. Kelly and Mr. Brown's motions shall be filed in CR20251060-001, but that the Court has considered the motions as to both cause numbers.

Mr. Myers informs the Court he is ready to proceed with the Change of Plea.

The Court questions the Defendant regarding his understanding of the terms and conditions of the plea agreement, the possible consequences thereof, and the constitutional rights he waives by entering the plea.  
As to CR20251060-001:

The Defendant enters a plea of guilty to the crime of AMENDED COUNT FOURTEEN: STALKING, a Class Five Felony, committed on or about September 12, 2024 through February 22, 2025.  
As to CR20251454-001:

The Defendant enters a plea of guilty to the crime of AMENDED COUNT ONE: AGGRAVATED HARASSMENT, a Class Six Felony, committed on or about March 16, 2025.

The Court questions the Defendant regarding the factual basis for the plea.

There being no factual basis for the plea,

Pursuant to *State v. Donald*,

The Court questions the Defendant regarding his understanding of the terms and conditions of the plea offer and the possible consequences should the Defendant be convicted on all charges.

THE COURT FINDS that there is no factual basis for the plea agreement.

THE COURT FURTHER FINDS that the Defendant has knowingly, intelligently and voluntarily rejected the plea, as he is unable to provide a factual basis.

IT IS ORDERED that the Status Conference Re: Trial Date on July 14, 2025, is affirmed.
