DECLARATION OF CHRISTOPHER J. CORDOVA

I, Christopher J. Cordova, declare as follows:

1. I am an individual residing in the State of Colorado. I am the operator of the YouTube channel known as Denver Metro Audits (<https://www.youtube.com/@DenverMetroAudits>). I am the sole member of Executive Lens LLC, a Colorado limited liability company (“Executive Lens”).

2. I submit this declaration in support of my request for issuance of a subpoena to Google, LLC d/b/a YouTube (“YouTube”), pursuant to the Digital Millennium Copyright Act (“DMCA”), 17 U.S.C. § 512(h) (the “DMCA Subpoena”). The purpose of the DMCA Subpoena is to identify the alleged infringer or infringers who posted substantial portions of Executive Lens’ audio-visual work on the YouTube channel <https://www.youtube.com/@Destination2Truth> without its authorization, and that posting infringes on its copyright (the “Infringing Content”). I have personal knowledge of the facts contained herein and, if called upon to do so, I could and would testify competently thereto.

3. On June 14, 2025, I submitted a DMCA notification, via YouTube’s online DMCA notification form, identifying the Infringing Content on YouTube’s platform and providing the information required by 17 U.S.C. § 512(c)(3)(A). Attached hereto as Exhibit 1 is a true and correct copy of the email reflecting the information I submitted through YouTube’s online form, along with YouTube’s response to the DMCA notification. I subsequently assigned ownership of the copyright to the video to Executive Lens.

4. The purpose for which the DMCA Subpoena is sought is to obtain the identity of the alleged infringer or infringers, and such information will only be used for the purpose of protecting my rights under 17 U.S.C. §§ 100, *et seq.*
