) ~~PROPOSED~~ JUDGMENT

1 On April 15, 2025, Plaintiff Jose DeCastro filed a voluntary Request for Dismissal without
2 prejudice of Defendant Michael Pierattini eight days before the hearing on Defendant Michael
3 Pierattini's Motion for Terminating Sanctions, which was originally scheduled for April 23, 2025.

4 On April 23, 2025, the Court continued Defendant Michael Pierattini's Motion for
5 Terminating Sanctions until May 29, 2025, which was the same day as the hearing on Defendant
6 Michael Pierattini's Motion for Summary Judgment.

7 On May 1, 2025, Defendant Michael Pierattini filed a Motion to Vacate the Dismissal
8 without prejudice of Defendant Michael Pierattini to be heard concurrently with the continued
9 Motion for Terminating Sanctions on May 29, 2025.

10 On May 29, 2025, Defendant Michael Pierattini's (1) Motion to Vacate/Strike
11 Plaintiff Jose DeCastro's voluntary Request for Dismissal of the complaint against Michael
12 Pierattini, without prejudice, filed on April 15, 2025; (2) Motion for Terminating Sanctions; and,
13 (3) Motion for Summary Judgment all came on regularly for a hearing in the above-entitled court
14 on May 29, 2025. R. Paul Katrinak appeared on behalf of Defendant Michael Pierattini. Plaintiff
15 appeared in pro per. The Court took the matter under submission.

16 On July 3, 2025, having taken the matter under submission, the Court ordered as follows:

- 17 1. Defendant Michael Pierattini's Motion to Vacate or Strike Plaintiff Jose Castro's
18 Voluntary Dismissal without prejudice is GRANTED. The Court orders the dismissal
19 of the case without prejudice entered on April 17, 2025, on Plaintiff's Voluntary
20 Request for Dismissal is vacated as to Defendant Michael Pierattini only.
- 21 2. Defendant Michael Pierattini's Motion for Terminating Sanctions is GRANTED. The
22 Court orders Plaintiff's complaint against Pierattini dismissed, in its entirety, WITH
23 PREJUDICE. Further the Court orders Plaintiff to pay Defendant Pierattini additional
24 monetary sanctions under CCP § 2023.030 in the amount of \$4,560.00 (10 hrs. @
25 \$450hr + \$60 filing fee).
- 26 3. Defendant Michael Pierattini's Motion for Summary Judgment on Plaintiff's remaining
27 cause of action for "right of Publicity Torts" is DENIED, as moot.
