Hi Christopher,

I talked to a lawyer and I will have a strong case if I decide to sue you for loss of income.

I make around \$12 000 per month and if you pro rate that to 3 weeks you are looking at around \$9000 of damages plus attorney fees.

You already know the videos will be reinstated in 3 weeks through the counter notification system.

I'm giving you 48 hours to retract all your copyright strikes on my channel or I will start the legal process.








