Court now assigns this case for a Jury Trial on August 11, 2026 at 9:00 a.m. and Pre-Trial Conference on June 1, 2026 at 1:30 p.m. These hearings will be held in the Vermillion Circuit Court. Defendant is ORDERED to appear for said hearings. Defendant acknowledges the same in open Court. The Court sets an Omnibus date on May 26, 2026.
