Your compliance with this notice of default may still be required even though the appeal may have been dismissed by the Court of Appeal for other reasons.

Review the following information regarding the submission of the designation:

**FORMAT.** *Appellant's Notice Designating Record on Appeal (Unlimited Civil Case)* (form APP-003) can be used to designate the record. Form APP-003 is available at any courthouse or online at [www.courts.ca.gov/forms.htm](http://www.courts.ca.gov/forms.htm).

**SERVICE.** Someone over the age of 18 and not a party to the case must mail, deliver, or electronically send (serve) the *Appellant's Notice Designating Record on Appeal (Unlimited Civil Case)* to the other party/parties, and a proof of service must be filed. *Proof of Service (Court of Appeal)* (form APP-009) or *Proof of Electronic Service (Court of Appeal)* (form APP-009E) may be used.

**REPORTER'S TRANSCRIPT.** Pursuant to CRC, rule 8.130, when designating a reporter's transcript, you must specify the date of each proceeding to be included, and you may also specify any portions of designated proceedings that are not to be included in the record. **The appellant is responsible for paying for preparing a reporter's transcript, and these funds must be deposited with the court.** (See CRC, rule 8.130 for more information about this deposit and the permissible substitutes.)
